WHEREAS, Section 458 (a)(5)(v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Panlungsod to enact ordinances to regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the construction, improvement, repair and maintenance of the same;

WHEREAS, Section 458 (a)(5)(vi) of the same Code likewise empowers the Sangguniang Panlungsod to approve ordinances that regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon and when necessary in the interest of public welfare, authorize the removal of encroachments and illegal constructions in public places;

WHEREAS, to prevent the traffic congestion that causes major problem in the area within the jurisdiction of Barangay Bagumbayan, the Sangguniang Barangay of Barangay Bagumbayan passed Barangay Resolution No. 154, S-2017 Entitled:

/

**"RESOLUTION REGULATING THE FLOW OF TRAFFIC  
WITHIN THE TERRITORIAL JURISDICTION OF  
BARANGAY BAGUMBAYAN AND PRESCRIBING  
PENALTIES FOR VIOLATIONS THEREOF."**

*WHEREAS, indiscriminate parking by unconcerned residents and/or visitors in the area have affected the flow of traffic in the jurisdiction of Barangay Bagumbayan;*

*WHEREAS, the socio economic status of families have improved over the past decade enabling resident owners to own more than one vehicle per family, thereby requiring all resident vehicle owner to park in the designated parking area for its safety and to prevent the blocking of the driveways;*

*WHEREAS, the barangay experiences massive complaints due to the continuous problem of vehicular traffic on daily basis;*

*WHEREAS, an orderly flow of traffic and organized parking of vehicles, per street is also necessary to give way quickly to emergency response vehicles to arrive on time especially and during fire and evacuation, as well as during emergency situations like sending a resident to the hospital;*

*WHEREAS, there is a need to implement a new traffic scheme to restore peace and order in the streets in Barangay Bagumbayan for the safety and protection of barangay personnel implementing the same;*

*WHEREAS, it is incumbent upon the City Government to regulate the traffic situation and road conditions within its jurisdiction.*

**NOW, THEREFORE,**

**BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
REGULAR SESSION ASSEMBLED:**

**SECTION 1. TITLE – This Ordinance shall be known and referred to as the "NEW TRAFFIC SCHEME OF BARANGAY BAGUMBAYAN".**

**SECTION 2. REGULATION** - The following streets shall be regulated:

- a.) *Strictly no parking on the following streets:*
  - 1.) *San Pablo I*
  - 2.) *San Pablo II*
  - 3.) *Sto. Tomas*
  - 4.) *Sto. Niño*
  - 5.) *San Gabriel*
  - 6.) *San Jose*
  - 7.) *F. Santos Alley*
  - 8.) *Del Rosario Alley*
- b.) *One way with left side parking along from San Roque to Victorino Alley;*
- c.) *Calle Industria to Old Tawiran to end of San Roque II are two way street with left side parking only;*
- d.) *One way with left side parking only (Horizontal) San Roque I street from Calle Industria to Old Tawiran;*
- e.) *San Roque II Street from Old Tawiran are two way with left side parking only (horizontal) except in front of Bagumbayan Elementary School strictly no parking and no vendors allowed.*
- f.) *Left side parking only (Diagonal) along Manggahan Street. Strictly no parking and tow away zone on the right side;*
- g.) *Tow away zone, no loading and unloading, and no parking on both sides of Economia Street and Calle Industria.*
- h.) *Tow away zone and one way parking along San Roque II street to Old Tawiran;*
- i.) *Right side parking (Horizontal) along Calle Industria to Obrero after BALCUJODA Terminal. Culdesac/dead end strictly no parking and tow away zone.*
- j.) *All Homeowners in Barangay Bagumbayan that has PUJ with Barangay sticker (Pursuant to Brgy. Ordinance No. 008, S-2014) will be allowed to park at a designated parking area after BALCUJODA Terminal to Tawiran (Horizontal parking)*
- k.) *Mercury Avenue after 15 meters from E. Rodriguez Jr. Avenue right side parking only (Diagonal). Strictly no parking and tow away zone at the culdesac/dead end;*

- l.) No loading/Unloading along E. Rodriguez Avenue north bound after Robinson's Office to Eastwood Police Station 12;*
- m.) Pick-up and drop-off point will be transferred at Economia Street PUJ Rosario, Bagumbayan and UV Express Van. Rosario bound driver of UV Express and Van are mandatory to secure working clearance.*
- n.) Manggahan Street, Obrero Street and Calle Industria are intended for open space for evacuation for disaster preparedness.*
- o.) All streets, alleys and avenues within the territorial jurisdiction of Barangay Bagumbayan are strictly no parking for six wheeler to sixteen wheeler close van and truck;*
- p.) All private vehicles/PUJs vehicle owned by homeowners/renters with Barangay sticker are required to park one vehicle only in the designated parking space on a first come first serve basis. Visitors without sticker are allowed to park from 8:00 a.m. until 6:00p.m. only.*
- q.) Ten wheeler to sixteen wheeler trucks from F. Manalo Bridge, Barangay Manggahan, Pasig City going to Barangay Bagumbayan are strictly no entry.*

**SECTION 3. ENFORCEMENT** – *This Ordinance shall be enforced and implemented by the Department of Public Order and Safety (DPOS) and by the Barangay Public Safety Officers (BPSO) of Barangay Bagumbayan.*

**SECTION 4. INSTALLATION OF SIGNAGE TRAFFIC SCHEME** – *The Department of Public Order and Safety (DPOS) and the Barangay Bagumbayan are hereby mandated to install Traffic Signage indicating that the street is regulated to inform motorists, drivers, vehicle owners and the public in general.*

**SECTION 5. PENALTY** – *Any person or persons found violating the provision/s of this Ordinance shall be penalized in accordance with Appendix VI of Ordinance No. SP-1444, S-2004, also known as the Quezon City Traffic Management Code, as amended.*

*SECTION 6. SEPARABILITY CLAUSE – If, for any reason, any provision of this Ordinance is declared unconstitutional or invalid by a competent court, the other provisions hereof not affected by such declaration shall remain in full force and effect.*

*SECTION 7. REPEALING CLAUSE – All existing Ordinances, Resolutions, Local Executive Orders, Rules and Regulations inconsistent with any of the provisions of this Ordinance are hereby repealed and/or modified accordingly.*

*SECTION 8. EFFECTIVITY CLAUSE. – This Ordinance shall take effect immediately upon its approval.*

WHEREAS, to prevent the traffic congestion that causes major problem in the area within the jurisdiction of Barangay Pinyahan, the Sangguniang Barangay of Pinyahan passed the following Resolutions, as follows:

**BARANGAY RESOLUTION NO. 070, S-2017 ENTITLED:**

**"BARANGAY COUNCIL RESOLUTION APPROVING THE NO-PARKING ON BOTH SIDES/TOW AWAY ZONE, ONE WAY TRAFFIC SCHEME AND ONE-SIDE PARKING WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY PINYAHAN, QUEZON CITY."**

**BARANGAY RESOLUTION NO. 114, S-2017 ENTITLED:**

**"BARANGAY COUNCIL RESOLUTION APPROVING THE NO LOADING AND UNLOADING ZONE SCHEME WITHIN THE TERRITORIAL JURISDICTION OF BARANGAY PINYAHAN, QUEZON CITY."**

WHEREAS, double parking of vehicles on the different streets within the barangay has been the problem, specially the residents and commercial establishments who are using the road as parking area. In case of emergency condition it could possibly obstruct emergency vehicles that will respond to the urgency of the situation;

WHEREAS, the barangay experiences massive complaints due to the continuous problem of vehicle traffic on daily basis;

WHEREAS, an orderly flow of traffic and organized parking of vehicles, per street is also necessary to give way quickly to emergency response vehicles to arrive on time especially and during fire and evacuation, as well as during emergency situations like sending a resident to the hospital;

WHEREAS, there is a need to implement a new traffic scheme to restore peace and order in the streets in Barangay Pinyahan for the safety and protection of barangay personnel implementing the same;

WHEREAS, it is incumbent upon the City Government to regulate the traffic situation and road conditions with its jurisdiction.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE – This Ordinance shall be known and  
referred to as the “New Traffic Scheme of Barangay Pinyahan”.

SECTION 2. REGULATION - The following streets shall be  
regulated:

I. NO PARKING ON BOTH SIDES/TOW AWAY ZONE ON THE  
FOLLOWING STREETS:

- a.) Kamias Road
- b.) V. Luna Avenue
- c.) NIA Road
- d.) East Avenue

II. ONE-WAY TRAFFIC SCHEME:

Entry Point and Exit Point:

- 1.) Entry to Mabilis St. (From V. Luna Ave. to  
Mapagmahal Street)
- 2.) Entry to Mapang-akit St. (From Mapagmahal St. to  
Matapang St.)
- 3.) Entry to Matatag St. (From Matapang St. to  
Mapagmahal St.)
- 4.) Entry to Matipuno St. (From Magalang St. to  
Mapagmahal St.)
- 5.) Entry to Makisig St. (From Mapagmahal St. to  
Magalang St.)
- 6.) Entry to Masigasig St. (From Mabilis St. to  
Mapagbigay St.)



- 7.) Entry to Matimpiin St. (From V. Luna Ave. to Matiyaga St.)
- 8.) Entry to Matapat St. (From Matiyaga to V. Luna Ave.)
- 9.) Entry to Masipag St. (From V. Luna Ave. to Matiyaga St.)
- 10.) Entry to Maginoo St. (From Matiyaga St. to V. Luna Ave.)
- 11.) Entry to Magiliw St. (From Mapagbigay St. to Maunlad and Mapagbigay Ext.)
- 12.) Entry to Mapagbigay Ext. (From Boracay, Matiyaga St. to Mapagbigay St.)

**SECTION 3. ENFORCEMENT** – This Ordinance shall be enforced and implemented by the Department of Public Order and Safety (DPOS) and by the Barangay Public Safety Officers (BPSO) of Barangay Pinyahan.

**SECTION 4. INSTALLATION OF SIGNAGE TRAFFIC SCHEME** – The Department of Public Order and Safety (DPOS) and the Barangay Pinyahan are hereby mandated to install Traffic Signage indicating that the street is regulated to inform motorists, drivers, vehicle owners and the public in general.

**AN ORDINANCE MANDATING THE TRICYCLE OPERATOR/S OPERATING IN THE CITY TO PROVIDE A PERSONAL ACCIDENT INSURANCE COVERAGE PROGRAM FOR THE PROTECTION OF TRICYCLE DRIVER/S AND PASSENGER/S AND PROVIDING FUNDS THEREFOR.**

WHEREAS, Section 374 of Presidential Decree No. 1460, as amended by Presidential Decree No. 1814, also known as the Insurance Code, states that: "It shall be unlawful for any land-transportation operator or owner of a motor vehicle to operate the same in public highways, unless there is in force, in relation thereto, a policy of insurance or guaranty in cash or surety bond issued in accordance with the provisions of this chapter to indemnify the death, bodily injury and or damage to property of a third party or passenger, as the case maybe, arising from the use thereof.";

WHEREAS, likewise, Section 5(b) of Commonwealth Act No. 146, as amended by Executive Order No. 202, empowers the Land Transportation Franchising Regulatory Board (LTFRB), "to issue, amend, revise, suspend or cancel Certificate of Public Convenience or permits authorizing the operation of public land transportation services that are provided by motorized vehicles, and to prescribe the appropriate terms and conditions thereof.";

WHEREAS, tricycle drivers and passengers are not covered by the above stated laws, instead the Local Government Unit (LGU) has the power to regulate the operation of tricycle and grant franchises for the operation thereof within the territorial jurisdiction of the city as stated in Section 458 (3)(vi) of Republic Act No. 7160;

WHEREAS, there are around 600,000 registered tricycle units found in the different parts of the Philippines, twenty-four thousand, seven hundred thirteen (24,713) of which is found in Quezon City;

WHEREAS, over the years, the tricycle sector have become a major social concern due to the worsening traffic, proliferation of colorum, accidents involving tricycles and an increasing number of families that are dependent on tricycle operation for livelihood;

WHEREAS, tricycle drivers and passengers are the most vulnerable when an accident happens and without personal insurance coverage to protect them;

WHEREAS, countless number of accidents involving tricycles colliding or bumping with other vehicles are bannered in the front pages of different newspapers of local, national and international circulation;

WHEREAS, the lack of "Personal Accident Insurance Coverage Program" is one of the major concern of the city and was the main reason for the crafting of this ordinance, to protect the drivers and passengers of tricycle.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE – This Ordinance shall be known as the "Personal Accident Insurance Coverage Program for Drivers and Passengers of Tricycle."

SECTION 2. DECLARATION OF POLICY – The Tricycle Management Code of Quezon City comprehensively addressed all aspects of operation, regulation and social protection for the tricycle sector and as a matter of the city's intensified effort, providing Personal Accident Insurance Coverage Program for Drivers and Passengers shall be an integral part of this policy prior to the issuance, renewal and updating of tricycle franchise.

SECTION 3. PERSONAL ACCIDENT INSURANCE COVERAGE – This Ordinance shall cover drivers and passengers of tricycle plying within the territorial jurisdiction of the city with a valid license and franchise.

**SECTION 4. ENROLLMENT OF DRIVERS AND PASSENGERS** – All owners/operators are the one responsible for securing a personal accident insurance policy as mandated by this Ordinance for the protection of the drivers and passengers.

**SECTION 5. PERSONAL ACCIDENT INSURANCE POLICY** – When the injury incurred in any of the following losses stipulated in the insurance policy coverage, the victim shall be indemnified by the Insurance Company for the corresponding compensation based on the principal sum.

**SECTION 6. THE TRICYCLE FRANCHISING BOARD (TFB) OF QUEZON CITY** –The Tricycle Franchising Board (TFB) is hereby tasked by this Ordinance:

- a) To make an inventory of all passenger tricycle and tricycle-for-hire operating in the city with existing franchise to determine their actual present numbers.
- b) To facilitate and supervise the implementation of the Personal Accident Insurance Coverage Program for Tricycle Drivers and Passengers.
- c) No Personal Accident Insurance Coverage Program for Drivers and Passengers mean No Issuance, Renewal or Updating of their existing Tricycle Franchise.
- d) Non-Compliance to this Ordinance is subject for the cancellation of their franchise.

**SECTION. 7. SUBSIDY** – For the first year of the implementation of this Ordinance, the city shall subsidize the total amount of the Personal Accident Insurance Coverage Program due from the tricycle operators.

**SECTION 8. BUDGET ALLOCATION** – The city shall allocate Twenty Million Pesos (P20,000,000.00) for this purpose.

**SECTION 9. APPLICATION FOR SUBSIDY** – The tricycle operators shall apply directly to the City's Tricycle Franchising Board (TFB) to avail of the subsidy.

**SECTION 10. ONE YEAR GRACE COVERAGE PERIOD TO COMPLY** – The tricycle operators are given a grace period of one (1) year after the passage of this Ordinance to avail of the city's subsidy and to comply with the mandate of this Ordinance of insuring the driver/s and passenger/s of the tricycle/s after which they shall be penalized accordingly for non-compliance. In short, within one year after the approval of this Ordinance, all tricycle operators must avail of the subsidy being offered by the city.

SECTION 11. *PENALTY CLAUSE – The penalty for defying the mandate of this Ordinance shall be the suspension or cancellation of Certificate of Public Convenience or permit authorizing the operation of their tricycle/ s as public transportation.*

SECTION 12. *REPEALING CLAUSE – All local legislations and executive directives inconsistent or are in conflict with this Ordinance are hereby repealed or modified accordingly.*

SECTION 13. *SEPARABILITY CLAUSE – The provisions of this Ordinance are separable. If for any reason, any section of this Ordinance shall be declared to be unconstitutional or invalid, the validity of the other provisions shall not be affected and shall continue to be in full force and effect.*

SECTION 14. *EFFECTIVITY – This Ordinance shall take effect on the day following its full publication for two (2) consecutive weeks in a newspaper of general circulation.*

*WHEREAS, the state, as guaranteed by the Constitution of the  
Republic of the Philippines, shall protect and promote the right to  
health and protect the right of the people to a balanced and healthful  
ecology;*

*WHEREAS, Republic Act No. 9711 or the Food and Drug  
Administration (FDA) Act of 2009, prohibits the manufacture,  
importation, exportation, sale, offering for sale, distribution, transfer,  
non-consumer use, promotion, advertising, or sponsorship of any  
health product that is adulterated, unregistered or misbranded and  
without the proper authorization from FDA;*

WHEREAS, Republic Act No. 7394 or the Consumer Act of the Philippines of 1992, prohibits the manufacture, importation, exportation, sale, distribution or transfer of any food, drug, device or cosmetic that is adulterated or mislabeled;

WHEREAS, the ASEAN Cosmetic Directive prohibits the deliberated addition of mercury, a toxic heavy metal, in cosmetic product formulations and sets a maximum limit of one part per million (ppm) for mercury as contaminant in cosmetics;

WHEREAS, the Minamata Convention on Mercury has scheduled the phase-out by 2020 of cosmetics, including skin lightening creams and soaps, with mercury content above one part per million (ppm);

WHEREAS, according to the FDA, World Health Organization (WHO) and the United Nations Environment, "mercury use in cosmetic products can have adverse effects including skin rashes, discoloring and scarring, and can reduce skin's resistance to bacterial and mycotic skin disorders... direct and prolonged exposure through the skin during repeated applications can cause damage to the brain, nervous system and kidneys";

WHEREAS, according to the WHO, "mercury in soaps, creams and other cosmetic products is eventually discharged into wastewater... where it becomes methylated and enters the food-chain as the highly toxic methylmercury in fish. Pregnant women who consume fish containing methylmercury transfer the mercury to their fetuses, which can later result in neurodevelopmental deficits in the children";

WHEREAS, the EcoWaste Coalition, a non-profit toxics watch group that has been tracking mercury in cosmetics since 2011, has exposed the illegal sale of mercury-laden skin whitening products in some retail establishments in Quezon City in clear violation of FDA-issued advisories;

WHEREAS, the FDA has sought the assistance of local government units, as well as enforcement agencies, in identifying and apprehending the importers, distributors and retailers of such mercury-laden cosmetics.



NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN  
REGULAR SESSION ASSEMBLED:

SECTION 1. PURPOSE – This Ordinance is enacted to ensure strict compliance by business and commercial establishments, as well as street, “tiangge” and online vendors, to the national regulation banning the sale of cosmetics containing mercury above the one ppm limit set by the FDA in line with the ASEAN Cosmetic Directive.

SECTION 2. OBJECTIVES – The objectives of this Ordinance are:

- a. To halt the illegal manufacture, importation, marketing and promotion, distribution and sale of cosmetic products not compliant with the state and ASEAN policy on mercury in cosmetics.
- b. To promote citizen awareness about the health and environmental hazards of consuming mercury-containing cosmetics.
- c. To ensure the environmentally-sound management of banned, recalled and/or confiscated mercury-containing cosmetics.

SECTION 3. SCOPE – This Ordinance shall apply to cosmetics as defined in R.A. No. 9711, such as but not limited to, personal care products such as creams, lotions and soaps that are designed to lighten or whiten the color of the skin.

SECTION 4. REQUIREMENTS – This Ordinance shall require that:

- a. All manufacturers, importers, distributors, wholesalers and retailers, including street, “tiangge” and online vendors in Quezon City, shall cease and desist from engaging in business activities involving the production and/or trade of mercury-laden cosmetics.

- b. All banned, recalled and/or confiscated stocks of cosmetics containing mercury shall be returned to the manufacturers or the exporting country/ies at the expense of the concerned manufacturers, importers, distributors, wholesalers, retailers or vendors for environmentally-sound disposal.
- c. If ownership of the banned, recalled and/or confiscated cosmetics cannot be determined, the same shall be temporarily kept at a secured place for environmentally-sound disposal in coordination with the Department of Environment and Natural Resources (DENR), Environmental Protection and Waste Management Department (EPWMD), FDA and other relevant agencies.

**SECTION 5. PROHIBITED ACTS** – This Ordinance shall prohibit the following:

- a. The manufacture, importation, marketing and promotion, distribution and sale of cosmetics with mercury content in excess of one ppm.
- b. The sale, wholesale or retail, of cosmetics that have not been authorized by the FDA and/or have not complied with the labeling requirements as required by the FDA.
- c. The open dumping, open burning and/or disposal of banned, recalled and/or confiscated mercury-containing cosmetics along with regular city solid waste.

**SECTION 6. PENALTIES** – Any violation of this Ordinance shall be punishable as follows:

First Offense – A fine of two thousand pesos (Php2,000.00) and confiscation of banned cosmetic products.

Second Offense – A fine of three thousand pesos (Php3,000.00) and suspension to operate business until compliance with this Ordinance.

*Third Offense - A fine of five thousand pesos (Php5,000.00), imprisonment of thirty (30) days or cancellation of business license given by the City, or both, at the discretion of the court.*

*In addition to the penalties above, all those convicted by the court shall also be required to render thirty (30) days of community service, to be determined by the local government authorities concerned.*

**SECTION 7. DUTY FOR IMPLEMENTATION** – *The City Health Department shall lead in the strict implementation of this Ordinance. It shall be the duty of the implementing officer to:*

- 1. Disseminate the necessary information that will inform and enjoin the general public, particularly concerned business establishments, to abide by this Ordinance.*
- 2. Coordinate with the Public Affairs and Information Services Office, Business Permits and Licensing Office (BPLO), Environmental Protection and Waste Management Department (EPWMD) and other relevant offices for the implementation of this Ordinance.*
- 3. Coordinate with the FDA, DENR and other relevant national government agencies for the implementation of this Ordinance.*

**SECTION 8. INFORMATION AND EDUCATION CAMPAIGN** – *The City Health Department in cooperation with the Public Affairs and Information Services Office (PAISO) and Environmental Protection and Waste Management Department (EPWMD) shall conduct a wide information and education campaign on the provisions of this Ordinance, with the assistance of concerned government agencies and non-government organizations.*

**SECTION 9. SEPARABILITY CLAUSE** – *If any section or part of this Ordinance shall be declared invalid or unconstitutional, the other provisions not affected by such a ruling shall remain in full force and effect.*

*SECTION 10. REPEALING CLAUSE – All ordinances, resolutions, local executive orders, or administrative issuances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.*

*SECTION 11. EFFECTIVITY – This Ordinance shall take effect thirty (30) days after its publication in a newspaper of general circulation.*

WHEREAS, it is the policy of the State to promote the family as the foundation of the nation, strengthen its solidarity and ensure total development;

WHEREAS, Republic Act No. 8972 or the Solo Parent Act of 2000 states that it shall develop a comprehensive program of services for Solo Parents and their children which shall be carried out by the Department of Social Welfare and Development (DSWD), Department of Health (DOH), Department of Education Culture and Sports (DECS) or DepEd and among others;

WHEREAS, Republic Act No. 7277, otherwise known as the Magna Carta for Disabled Persons, declares that the local government units are mandated to support the rehabilitation of disabled persons in order to foster their capacity in attaining a more meaningful and productive life;

WHEREAS, the Quezon City Government has instituted several programs in education, housing, social welfare, among others and approved various ordinances that would redound towards the benefit of the Disabled and Solo Parents and their children;

WHEREAS, on February 17, 2014, the 19<sup>th</sup> Quezon City Council enacted Ordinance No. SP-2269, S-2014 entitled: "An Ordinance Establishing the Basic Education Enhancement Program of Quezon City" which aims to provide its constituents with the basic education materials in order to alleviate the financial burden on the part of the indigent families and bonafide residents of the City;

WHEREAS, Solo Parents, being the sole provider of the family, most of them are experiencing financial difficulties, as such, it is only proper for the City Government to provide for the basic educational materials to their children;

WHEREAS, similar to Solo Parents, People with Special Challenges generally known as Persons with Disability (PWD) belong to a sector that need preferential consideration for the improvement of their well-being and their integration into the mainstream of the society.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. An additional subsection o) Differently abled or Persons with Disability and p) Solo Parent, will be added to Section 3 (Definition of Terms) of Ordinance No. SP-2269, S-2014. The definition of which will be the definition provided for by Republic Act No. 7277 and Ordinance No. SP-2374, S-2014, respectively.

SECTION 2. An additional paragraph shall be added to Section 4 (Qualifications of Student Applicants), which will read as follows:

Further, the child/children of a Solo Parent shall be an immediate beneficiary of this Ordinance provided that they possess the qualification of subsection "a" and "b" of this section. In addition, the Solo Parent should possess a Solo Parent Identification Card issued by the Quezon City Social Services Development Department or registered to the same.

Furthermore, Persons with Disability (PWD) registered in the Quezon City Persons with Disability Affairs Office (QCPDAO) shall likewise benefit from this Ordinance provided that they possess the qualification of subsection "a" and "b" of this section.

**SECTION 3. REPEALING CLAUSE** – All ordinances, executive orders, rules and regulations and other administrative issuance or provisions thereof which are contrary to or inconsistent herewith are hereby repealed or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE** – If any provision of this Ordinance is declared invalid or unconstitutional, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

**SECTION 5. EFFECTIVITY** – This Ordinance shall take effect immediately upon its approval.

WHEREAS, Republic Act No. 7279, or the "Urban Development and Housing Act of 1992" contemplates the policy of the State to undertake, in cooperation with private sector, a comprehensive and continuing Urban Development and Housing Program which shall uplift the living conditions of the underprivileged and homeless citizens in urban areas and in resettlement areas;

WHEREAS, estate tax is the tax on the right to transmit property at death and on certain transfers by the decedent during his lifetime. These are made by the law equivalent to testamentary dispositions, as provided in the "National Internal Revenue Code of 1997";

WHEREAS, statistics from the Bureau of Internal Revenue indicates that there has been a wide mismatch between the number of estate tax return filed compared to number of deaths reported. Said statistics revealed that substantial number of Filipinos may not be familiar with estate tax and as a result the tax liabilities that accrued may have accumulated huge penalties and surcharges that became burdensome to the family members and heirs of the deceased;

WHEREAS, almost too often, heirs will have to sell properties to the on-site occupants who could fund the estate tax including interest and penalties which is an additional burden to the informal settler families (ISFs);

WHEREAS, non-payment by the heirs of the estate tax after death of the registered owner of the properties will result in the locking up of the properties for development and limit the implementation of CMP Programs, Socialized Housing Projects and direct sale to the Community Associations;
