ORDINANCE Numbered 170

ORDINANCE FIXING THE LICENSE FEES ON CERTAIN BUSI-  
 NESSES AND OCCUPATIONS WITHIN THE JURISDICTION  
 OF QUEZON CITY AND REPEALING ITEMS "2. BATH-  
 HOUSE AND SWIMMING POOLS - P12.00 PER ANNUM"  
 AND "3. REFRESHMENT PARLORS P25.00 PER ANNUM,"  
 UNDER OTHER BUSINESS AND OCCUPATION OF SCHE-  
 DULE C, CONTAINED IN ORDINANCE NUMBERED 10.

Be it ordained by the City Council of Quezon City,  
 that:

SECTION 1. All persons or establishments within the  
 jurisdiction of Quezon City, engaged in the kind of busi-  
 ness or occupation hereinbelow specified, shall pay to  
 the City Treasurer of Quezon City the following license  
 fees per annum:

Retail Liquor Dealers - - - - -	24.00
<u>Schedule - B</u>	
Dealers in gravel, broken-stone, adobe stone and sand - - - - -	16.00
Producers of Gravel, sand and adobe stones - - - - -	16.00
<u>Proprietors or Operators:</u>	
Hopia shops or Factories - - - - -	20.00
Box Factories (Wooden or Cardboard) -	20.00
Manufacturers of Concrete Pipes - - -	25.00
<u>Merchants or dealers:</u>	
Molasses and Tiki-tiki (darak) - - - -	20.00
Fire-wood and charcoal - - - - -	6.00
<u>Contractors:</u>	
Electrical Contractors - - - - -	16.00
<u>Other shops:</u>	
Shoe Repair shops - - - - -	8.00
<u>Refreshment Parlors:</u>	
Class "A" having accommodation for fifteen or more persons - - - - -	15.00
Class "B" having accommodation for less than fifteen persons - - - - -	12.00
Class "C" selling small quantities of halo-halo and mongo con hielo --	6.00

SEC. 2. The items "2. Bath-house and swimming pools-  
 P12.00 per annum," and "3. Refreshment parlors - P25.00  
 per annum," under Other Business and Occupation of Sche-  
 dule C, contained in Ordinance Numbered 10, are hereby  
 repealed.

SEC. 3. This Ordinance shall take effect upon its  
 passage.
