N PROPOSED RESOLUTION

A RESOLUTION GRANTING A MARKET FRANCHISE TO 3A BOYS CORPORATION, INC. FOR THE OPERATION OF COMMONWEALTH MARKET LOCATED AT COMMONWEALTH AVENUE, BARANGAY COMMONWEALTH, QUEZON CITY, IN ACCORDANCE AND SUBJECT TO THE PERTINENT PROVISIONS OF ORDINANCE NO. SP-2459, S-2015, OTHERWISE KNOWN AS THE REVISED QUEZON CITY MARKET CODE.

WHEREAS, City Ordinance No. 2459, S-2015, otherwise known as the Revised Market Code, was enacted by the Quezon City Council in order to integrate all laws and ordinances for a more efficient and organized system of regulation of public markets and market-related activities to safeguard the interest of consumers;

WHEREAS, it is the legislative intent of the Quezon City Council to require new and all existing private markets to secure market franchise from the Quezon City Council pursuant to City Ordinance No. 2459, S-2015, otherwise known as the Revised Market Code;

WHEREAS, Article III, Section 1, paragraph 1.4 of City Ordinance No. 2459, S-2015, otherwise known as the Revised Market Code, provides that no person, partnership or corporation shall operate a private market within Quezon City without first securing a franchise from the City Council;

WHEREAS, the Commonwealth Market is an existing wet and dry market located at Commonwealth Avenue, Barangay Commonwealth, Quezon City being operated by 3A Boys Corporation, Inc.;

WHEREAS, 3A Boys Corporation, Inc. has complied with all documents necessary for the operations of a private market that will entitled the corporation to be granted with a market franchise by the Quezon City Council pursuant to City Ordinance No. 2459, S-2015, otherwise known as the Revised Market Code.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a market franchise to 3A Boys Corporation, Inc. for the operation of Commonwealth Market located at Commonwealth Avenue, Barangay Commonwealth, Quezon City, in accordance and subject to the pertinent provisions of Ordinance No. SP-2459, S-2015, otherwise known as the Revised Quezon City Market Code.

RESOLVED, FURTHER, that the market franchise granted under this Resolution shall be for a period of five (5) years and subject to franchise fee and annual franchise tax provided Article III, Section 1, paragraph 1.4.1 and 1.4.3 of City Ordinance No. 2459, S-2015, otherwise known as the Revised Market Code.

RESOLVED, FURTHERMORE, that in case 3A Boys Corporation Inc. sell and/or transfer the ownership of the Commonwealth Market to any person or entity, the new owner shall secure a new market franchise from the Quezon City Council.
