PROPOSED RESOLUTION NO. ____ S-2019

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO OMNI HAULING SERVICES, INC. FOR THE CONSTRUCTION AND OPERATION OF A GARAGE FOR WASTE COLLECTION TRUCKS, MOTORPOOL, TRANSFER STATION AND OFFICE BUILDING LOCATED AT LOT 1, 1-B, 1-E, 2-A, PAYATAS ROAD GROUP 2, AREA B, BARANGAY PAYATAS, QUEZON CITY.

WHEREAS, OMNI HAULING SERVICES, INC, represented by Mr. Aniceto M. Franco, is applying for a Special Use Permit for the construction and operation of a garage for waste collection trucks, motorpool, transfer station and office building located at Lot 1, 1-B, 1-E, 2-A, Payatas Road Group 2, Area B, Barangay Payatas, Quezon City;

WHEREAS, the garage complies conditions a, b, c, e, i and j of SUP prior to its approval, while conditions d, f, g, and h, shall be observed upon its operation at all times in accordance with the provision of Article VII Section 52.9 of Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance and its implementing rules and regulation, a Special Use Permit is required for this projects;

WHEREAS, the proposed project will not adversely affect the public health, safety and welfare of the citizenry. It will also provide and promote livelihood;

WHEREAS, the applicant has complied with all requirements for the issuance of a Special Use Permit and Barangay Payatas interposes no objection for the operation of the applicant's waste collection trucks garage and approves the conduct of its business in their area.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize as it does hereby authorize the issuance of a Special Use Permit to OMNI Hauling Service, Inc., for the construction and operation of a garage for waste collection trucks, motorpool, transfer station and office building located at Lot 1, 1-B, 1-E, 2-A, Payatas Road Group 2, Area B, Barangay Payatas, Quezon City.

RESOLVED FURTHER, that the Special Use Permit shall be annulled by operation of law in case the LTFRB revokes its franchise and upon violation of applicable special laws, rules and regulation.
