

Ordinance No. SP-50, 3-93

ORDINANCE

APPROPRIATING THE AMOUNT OF ONE MILLION FOUR HUNDRED NINE THOUSAND ONE HUNDRED PESOS (P1,409,100.00) FOR THE CONSTRUCTION OF THE COVER OF THE BASKETBALL COURT AT PROJECT 8, QUEZON CITY.

WHEREAS, the state recognizes the vital role of the youth in nation building as declared in Article II of the 1987 Constitution of the Republic of the Philippines;

WHEREAS, the construction of a "covered court" in a community is pursuant to the avowed state policy of promoting the physical, moral and social well-being of the youth;

WHEREAS, there already exists an open basketball court at the corner of Road 11 and 12, Barangay Bahay-Toro, Project 8, Quezon City which could not be used during rainy days and the better part of the wet season;

WHEREAS, the said basketball court could be put to more uses not only for sport purposes but also for cultural and social activities if only it is covered;

NOW, THEREFORE,


BE IT ENACTED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby appropriated the


amount of One Million Four Hundred Nine Thousand One Hundred Pesos (P1,409,100.00) or so much thereof as may be necessary for the construction of the cover of the basketball court at the corner of Road 11 and 12 Barangay Bahay Toro, Project 8, Quezon City from any available funds in the City Treasury.

SECTION 2. This Ordinance shall take effect upon its approval.


