Ordinance No. SP-99, S-93

ORDINANCE CREATING A JOINT LEGISLATIVE-EXECUTIVE COMMITTEE ON BARANGAY BOUNDARIES (CBB), DEFINING ITS POWERS AND FUNCTIONS AND FOR OTHER PURPOSES.

Introduced by Councilor FRANZ S. PUMAREN.

WHEREAS, Section 118(a) of the Local Government Code empowers the sangguniang panlungsod to settle boundary disputes involving two (2) or more barangays of the City;

WHEREAS, clearly defined city and barangay boundaries are reflective of the clarity of its identity and self-image;

WHEREAS, the last city-wide land survey in Quezon City was undertaken in the late sixties;

WHEREAS, the Quezon City's political map has undergone many changes in the past three (3) decades;

WHEREAS, there has since been many cases of conflicting claims of territorial jurisdiction among the barangays of Quezon City;

WHEREAS, barangay leaders must be aware of their respective territorial jurisdictions to facilitate the efficient and effective performance of their functions;

WHEREAS, there have been a number of unfinished attempts in the past to resolve this problem, the latest of which was that of the former Committee on Barangay Boundaries created by Office Order No. 2 signed on September 17, 1986;

WHEREAS, it is to the best interest of Quezon City to adopt and promote clearly delineated and uniform boundaries for the City and its composite barangays;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Joint Legislative-Executive Committee on Barangay Boundaries (referred to as CBB) will have the following powers and functions:

- (a) to redefine the official boundaries of the barangays comprising Quezon City;
- (b) to identify barangays with ambiguous or vague territorial jurisdiction and resolving such cases;
- (c) to recommend appropriate measures in furtherance of the above-mentioned purposes;
- (d) to propose legislation to the City Council outlining a uniform delineation to be adopted and promoted by all pertinent government agencies.

SECTION 2. The CBB shall be comprised of one (1) representative each from the following offices:

- (a) Committee on City Planning, Building and Zoning Regulation (CCPEZR), who shall be designated as Chairperson;
- (b) Barangay Operations Center (BOC), who shall be designated as Vice-Chairperson;
- (c) City Planning and Development Office (CPDO), member;
- (d) City Assessor's Office (CAO), member;
- (e) City Engineer's Office (CEO), member;
- (f) Commission on Elections (COMELEC), member;
- (g) Land Management Bureau (LMB), member; and
- (h) President of the Liga Ng Mga Barangay, member.

SECTION 3. The CBB is authorized to avail of the services and assistance of any government department and office in the execution of its function.

SECTION 4. All ordinances and executive orders inconsistent with this Ordinance are hereby repealed and/or modified accordingly.

SECTION 5. The CBB is created on an ad hoc capacity and shall be dissolved upon completion of its mandate.

SECTION 6. This Ordinance shall take effect upon its approval.
