ORDINANCE NO. SP-15, S-94

AN ORDINANCE AMENDING SECTION 15 OF ORDINANCE NO. SP-15, S-92 ENTITLED "AN ORDINANCE FRANCHISING AND REGULATING THE OPERATION OF MOTORIZED TRICYCLES IN QUEZON CITY TO BE KNOWN AS THE QUEZON CITY TRICYCLE OF 1992", SO AS TO AMEND THE IMPOSITION OF PENALTIES FOR VIOLATION THEREOF.

Introduced by Councilors VICTOR V. FERRER, JR., JOSEPH PETER S. SISON and BAYANI V. HIPOL.

Co-Introduced by Councilors Alberto M. Galarpe, Herminio "Butch" C. Bautista and Connie C. Angeles.

WHEREAS, Ordinance No. SP-15, S-92 already provides for the rules and regulations of motorized public utility tricycles but does not impose any exact penalty for a specific violation thereof;

WHEREAS, without any specific penalty imposed upon violations of the aforesaid rules and regulations, there is no legal sanction to assure compliance of the same by tricycle operators and/or drivers and many difficulties would be encountered in implementing the same rules and regulations;


WHEREAS, the fines and penalties presently imposed by the Implementing Guidelines Governing Tricycle Operations in Quezon City are impracticably high for tricycle operators and/or drivers, who are charged even more in terms of fines, than taxi operators/drivers and other similar public utilities;

WHEREAS, the strict enforcement of said rules and regulations is primarily for the protection of the public, particularly the riding public;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 15 of Ordinance No. SP-15, S-92, entitled "An Ordinance Franchising and Regulating the Operation of Motorized Tricycles in Quezon City to be known as The Quezon City Tricycle of 1992", is hereby amended to read as follows:



"Section 15. PENAL PROVISIONS - Violation of any of the provisions of the rules and regulations as provided for in this Ordinance by the tricycle operator and/or driver as the case may be shall be penalized as follows:


Operating without franchise	P500.00
Operating with expired franchise	P300.00
Operating without or incomplete body color or coding	P100.00
Operating without or incomplete body numbering, name of Tada and Quezon City	P100.00
Tricycles operating without, or with defective lights	P100.00
Tricycles operating without, or with defective mufflers	P100.00
Tricycle unit without interior lights	P100.00
Tricycle unit installed with unusually large decoration or fixture tending to obstruct from the view of side car number	P100.00
Allowing unlicensed and/or improperly licensed persons to drive	P500.00
Dirty and unsightly or dilapidated unit	P100.00
Use of unauthorized sidecar body number, change color configuration of unit	P100.00
Unregistered substitute or replacement of engine/chassis	P300.00

SECTION 2. Any existing ordinance, rule, instruction, executive order contrary to the foregoing are hereby amended, repealed or modified accordingly.

SECTION 3. This ordinance shall take effect immediately upon its approval.

**IMPLEMENTING GUIDELINES GOVERNING TRICYCLE
OPERATIONS IN QUEZON CITY
(CITY ORDINANCE NO. SP-15, S-92)**

XX. PENAL PROVISIONS

Violation of any of the provisions of this Ordinance shall be penalized by a fine of not less than One Hundred Pesos (P100.00) but not more than One Thousand Pesos (P1,000.00) or imprisonment for a period not exceeding six (6) months or both such fine and imprisonment at the discretion of the Court.

Unless otherwise herein specifically provided, violations of the Ordinance No. SP-15, S-92 by tricycle drivers and operators shall be meted out with the penalties for such violations as provided for in R.A. 4136 as amended by B.P. No. 398 and City Ordinance No. NC-128, S-89 which are hereby adapted.



C. MISCELLANEOUS PENAL PROVISIONS

1. Traffic enforcement officers, Tricycle Regulation Unit enforcers and its deputized agents shall impound or cause the impounding of motorized tricycle upon their determination that any of the aforesaid violations have been committed.
2. In case violations where the Driver's ID Card cannot be confiscated because the driver left the vehicle unattended or has been absconded, the apprehending officer may impound the tricycle unit involved and hold the same pending the resolution of the case; The owner/operator may be ordered to surrender the TRU issued ID card of his driver to the TRU.
3. When there are defects in the tricycle unit/sidecar that have to be repaired or remedied or certain required markings have to be painted thereon, the Certificate of Registration and the Official Receipts shall be held by the TRU until defects are removed and/or required markings have been properly made.
4. Failure of the driver/operator to settle his case within fifteen (15) days from date of apprehension will cause suspension of his TRU issued Driver's ID Card and/or franchise.
5. The TRU may use all reasonable means to enforce all provisions of the Implementing Guidelines, including the impounding of the tricycle unit to prevent further violations or disregard of applicable laws, rules and regulations.
6. If, as a result of negligence or recklessness or unreasonable fast driving, any accident occurs resulting in death or injury of any person, the motorized tricycle operator/driver at fault shall

4. upon conviction be punished under the provision of the Revised Penal Code.
 7. Using the tricycle unit in the commission of a crime shall likewise cause the impounding of the tricycle unit.
