ORDINANCE NO. SP-209, S-94

AN ORDINANCE GRANTING A MONTHLY NON-COMMUTABLE ALLOWANCE (REPRESENTATION ALLOWANCE) TO ALL ASSISTANT DIVISION CHIEFS AND SECTION CHIEFS OR POSITION DESIGNATED AS SUCH, IN THE AMOUNT OF NINE HUNDRED PESOS (P900.00) AND SEVEN HUNDRED FIFTY PESOS (P750.00), RESPECTIVELY, AND FOR OTHER PURPOSES AND APPROPRIATING THE AMOUNT OF THREE MILLION SIX HUNDRED NINETY-THREE THOUSAND SIX HUNDRED PESOS (P3,693.600) TO BE FUNDED IN THE 1995 ANNUAL BUDGET.

WHEREAS, in the performance of their assigned tasks, duties and responsibilities, Assistant Division Chiefs and Section Chiefs oftentimes entail incidental expenses which they have no other recourse but to personally shoulder without refund;

WHEREAS, in order to address this predicament being encountered by the said personnel, there is a need to grant them a monthly non-commutable allowance (representation allowance) which will ultimately redound to the benefit of the City Government thru an efficient and effective delivery of public service;

WHEREAS, under Section 458 (a) (i) (viii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Council has the power, among others, to determine the allowances of the officials and employees paid wholly or mainly from city funds;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN SESSION ASSEMBLED:

Section 1. There is hereby granted a monthly non-commutable allowance (representation allowance) to all Assistant Division Chiefs and Section Chiefs or positions designated as such in the amount of Nine Hundred Pesos (P900.00) and Seven Hundred Fifty Pesos (P750.00) each, respectively.

Section 2. There is hereby appropriated the amount of THREE MILLION SIX HUNDRED NINETY THREE THOUSAND SIX HUNDRED PESOS (P3,693,600.00) in the 1995 Annual Budget.

Section 3. This Ordinance shall take effect on January 1, 1995.


