ORDINANCE NO. SP-311, S-95

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED THIRTY-SEVEN THOUSAND FIVE HUNDRED PESOS (P137,500.00) FOR THE VICTIMS OF FIRE OF APRIL 6, 1995 AT 7:15 P.M. AT MATUTUM ST., BARANGAY MANRESA, WHICH GUTTED AND AND ST., BARANGAY MANRESA, MUTUTAM DESTROYED SEVERAL HOUSES RENDERING HOMELESS SIXTY-THREE SAID AMOUNT TO BE TAKEN FROM (63) FAMILIES, APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE CY 1995 ANNUAL BUDGET.

WHEREAS, on April 6, 1995, a re-structural fire occurred at Matutum Street, Barangay Manresa, Quezon City, which destroyed several houses and properties rendering homeless at least some forty-nine (49) homeowners and fourteen (14) family renters and the veracity of said fortuitous event was duly certified by the Barangay Captain who has jurisdiction in the area;

WHEREAS, the owners of the burned houses including immediate members of their affected families are presently relying on the help of their good Samaritan neighbors and friends for subsistence;

WHEREAS, the City Government can at least lessen sufferings of those fire victims through the much needed financial assistance;

WHEREAS, to alleviate their suffering to a lesser degree, financial assistance will go along way;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby appropriated from the Calamity Fund of the City, the amount of ONE HUNDRED THIRTY-SEVEN THOUSAND FIVE HUNDRED PESOS (P137,500.00) to be distributed as follows:

- a. P2,500 each to the 49 house owners;
- b. P1,000.00 each to the 14 renters.

SECTION 2. The Office of the Barangay Council, Barangay Manresa, Social Services Development Department and the City Council, all of Quezon City, thru their duly authorized representatives shall coordinate and facilitate for the immediate implementation of this Ordinance.

SECTION 3. This Ordinance shall take effect upon its approval.
