ORDINANCE NO. SP-376, S-96

AN ORDINANCE GRANTING AMUSEMENT TAX EXEMPTION TO THE PHILIPPINE NATIONAL RED CROSS, QUEZON CITY CHAPTER, FOR THE FILM SHOWING OF "GOLDENEYE", FOR THE DURATION OF ITS SHOWING, BEGINNING LAST JANUARY 4, 1996, AS PROVIDED FOR UNDER PD 1643 AND SECTION 192 OF RA 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Section 192 of the Local Government Code provides that "Local Government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary";

WHEREAS, the Philippine National Red Cross or PNRC is a non-governmental organization that helps our countrymen in times of distress, calamities and the like;

WHEREAS, the Philippine National Red Cross needs to raise funds for this noble cause;

WHEREAS, pursuant to Section 4 (b) of PD 1643, the PNRC "shall be exempt from payment of all duties, taxes, fees and other charges of all kinds on all importations and purchases for its exclusive use, on donations for its disaster relief and other Red Cross services, and in its benefits and fund raising drives, all provisions of laws to the contrary notwithstanding";

WHEREAS, the Quezon City Chapter of PNRC is raising funds through the film showing of "Goldeneye" for the duration of its showing which began last 4 January 1996;

WHEREAS, the grant of exemption from the payment of amusement taxes constitutes Quezon City's financial contribution to the Quezon City Chapter of PNRC;

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Amusement tax exemption is hereby granted to the Quezon City Chapter of the Philippine National Red Cross (PNRC) for the film showing of "Goldeneye" for the duration of its showing which began last 4 January 1996.

SECTION 2. This Ordinance shall take effect upon its approval.
