ORDINANCE NO. SP- 386, S-96

AN ORDINANCE GRANTING AMUSEMENT TAX EXEMPTION TO THE PHILIPPINE NATIONAL RED CROSS, MANILA CHAPTER, FOR THE BACK TO BACK CONCERT OF RIVER MAYA AND THE ERASERHEADS, TO BE SHOWN ON MARCH 2 AND 26, 1996 AT THE KAMPO, WEST AVENUE, QUEZON CITY, AS PROVIDED FOR UNDER SECTION 192 OF R.A. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Section 192 of the Local Government Code provides that "Local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary;"

WHEREAS, the Philippine National Red Cross, or PNRC, is a non-governmental organization that helps our countrymen in times of distress, calamities and the like;

WHEREAS, the PNRC needs to raise funds for this noble cause;

WHEREAS, pursuant to Sec. 4 (b) of PD 1643, the PNRC "shall be exempt from payment of all duties, taxes, fees and other charges of all kinds on all importations and purchases for its exclusive use, on donations for its disaster relief work and other Red Cross services, AND IN ITS BENEFITS AND FUND RAISING DRIVES, all provisions of laws to the contrary notwithstanding";

WHEREAS, the Manila Chapter of PNRC is raising funds through the back to back concert of River Maya and the Eraserheads to be shown on March 2 and 26, 1996 at the Kampo, West Avenue, Quezon City;

WHEREAS, the grant of exemption from the payment of amusement taxes constitutes Quezon City's financial contribution to the Quezon City Chapter of PNRC;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Amusement tax exemption is hereby granted to the Manila Chapter of the Philippine National Red Cross (PNRC) for the back to back concert of River Maya and the Eraserheads, to be shown on March 2 and 26, 1996 at the Kampo, West Avenue, Quezon City.

SECTION 2. This Ordinance shall take effect upon its approval.
