ORDINANCE NO. SP- 431, S-96

AN ORDINANCE GRANTING AMUSEMENT TAX EXEMPTION TO THE PHILIPPINE NATIONAL RED CROSS, QUEZON CITY CHAPTER, FOR THE ENTIRE DURATION OF THE FILM SHOWING OF "ERASER", STARTING 31 JULY 1996, AS PROVIDED FOR UNDER PD 1643 AND SECTION 192 OF R.A. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, Section 192 of the Local Government Code provides that "local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary";


WHEREAS, pursuant to Section 4 (b) of PD 1643, the Philippine National Red Cross or PNR "shall be exempt from payment of all duties, taxes, fees and other charges of all kinds on all importations and purchases for its exclusive use, on donations for its disaster relief works and other Red Cross services, and in its benefits and fund-raising drives, all provisions of laws to the contrary notwithstanding";

WHEREAS, the PNR is a non-governmental organization that helps our countrymen in times of distress, calamities and the like;


WHEREAS, the PNR needs to raise funds to implement this noble cause;

WHEREAS, the PNR is raising funds through the film showing of "Eraser";

WHEREAS, the grant of exemption from the payment of amusement taxes constitutes Quezon City's financial contribution to the PNR;


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

entire duration of the film showing of "Eraser" beginning 31 July
1996.
