ORDINANCE NO. SP- **510**, S-97

AN ORDINANCE AUTHORIZING THE ISSUANCE OF A FRANCHISE TO GALLERA DE GUISON HERMANOS INC., TO ALLOW THE CONTINUATION OF THE OPERATION OF THE LALOMA COCKPIT WHICH FORMALLY STARTED ITS OPERATION IN 1902, SUBJECT TO THE TERMS AND CONDITIONS OF QUEZON CITY ORDINANCE NO. SP-463, S-96.

WHEREAS, the Laloma Cockpit, operated since 1902 by the Gallera De Guison Hermanos Inc., has been known for its fairness in cockfighting;

WHEREAS, numerous persons depend on its continuous operation for their livelihood;

WHEREAS, records show that the operation of this cockpit generates considerable amount in the form of revenue for the City;

WHEREAS, a franchise needs to be secured from the Sangguniang Panlungsod for its operation and maintenance, in compliance with the requirement of City Ordinance No. SP-463, S-96.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:



