WHEREAS, Northern Bingo is a domestic corporation duly organized and existing under and by virtue of laws of the Republic of the Philippines with principal office at Room 3-D, 3rd Floor, VS-I Building, 34 Kalayaan Avenue, Quezon City;

WHEREAS, the Philippine Amusement and Gaming Corporation (PAGCOR) has granted Northern Bingo Corporation an authority to operate bingo halls where bingo games may be played;

WHEREAS, under Republic Act No. 7160, the City Council has the authority to grant franchises, enact ordinances authorizing the issuance of permits or licenses and ordinances levying taxes, fees and other charges;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby granted to Northern Bingo Corporation or its assignee the sole authority to operate bingo hall at Nova Mall in Quezon City, and conduct therein bingo games.

SECTION 2. Northern Bingo Corporation shall secure a Mayor's Permit for the operation of the bingo hall and pay the required Mayor's permit fee as provided under the provisions of the Revenue Code of Quezon City.

SECTION 3. The authority to operate bingo hall granted herein shall be subject to the following limitations:

- a) The operation of the bingo hall shall only be within the specified location as cited above;
- b) The operation of bingo hall shall not include the playing of games not related to or other than the game of bingo.

SECTION 4. The grant of authority to operate the above cited bingo hall and bingo games herein shall be for a period of five (5) years, renewable for another 5 years at the option of the grantee.

SECTION 5. In lieu of the payment of business taxes, under the Quezon City Revenue Code a franchise fee of not more than one half (1/2) of one (1) percent of the gross revenue of Northern Bingo Corporation yearly shall be imposed and be paid every year.

SECTION 6. This Ordinance shall take effect immediately upon its approval.
