ORDINANCE NO. SP- 66 7 ,-8-98

AN ORDINANCE AUTHORIZING THE CAVITE, CAPIZ, CATANDUANES (CCC) NEIGHBORHOOD ASSOCIATION OF BARANGAY PALTOK TO CONSTRUCT, INSTALL AND MAINTAIN GATES WITHIN THEIR JURISDICTION FOR THE PURPOSE OF SECURITY AND MAINTENANCE OF PEACE AND ORDER.

WHEREAS, the Local Government Code of 1991 empowers local government units to enact measures necessary to promote the health and safety, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, in an ordinance passed by the Barangay Council of Barangay Paltok, First District, Quezon City, more specifically Ordinance No. 003, Series of 1998, recommending to the City Council of Quezon City, to allow the Cavite, Capiz, Catanduanes (CCC) Neighborhood Association to construct, install and maintain gates within their jurisdiction;

WHEREAS, the purpose of the installation of these gates is to maintain the peace and order situation as well as to minimize the intrusions of undesirable elements, particularly the "Akyat Bahay" and "Bukas Kotse" gangs;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Cavite, Capiz, Catanduanes (CCC) Neighborhood Association is hereby authorized to construct, install and maintain gates within their jurisdiction for the purpose of security and the maintenance of peace and order.

SECTION 2. The gates shall be closed between 10:00 p.m. up to 5:00 a.m of the following day..

SECTION 3. In case of emergencies, vehicles such as ambulance, fire truck, patrol vehicle, and other similar vehicles will be allowed to pass thru the gates.

SECTION 4. The expenses for the installation of the gates shall come from the budget of the barangay as approved by the City Council.

SECTION 5. The gates shall be manned in coordination with the Barangay Council of Barangay Paltok.

SECTION 6. This Ordinance shall take effect upon its approval.
