ORDINANCE NO. SP- 682 3-98

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) TO THE FAMILY OF THE LATE CARLOS RAMOS OF BARANGAY PALTOK, DISTRICT I, QUEZON CITY, THE AMOUNT TO BE ALLOCATED FROM THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS FOR THE PURPOSE.

WHEREAS, the Sangguniang Barangay of Paltok in their Barangay Resolution No. 087, Series of 1996, strongly urge for the extension of financial assistance to the bereaved family of the late Carlos Ramos;

WHEREAS, Mr. Carlos Ramos, is a former regular Barangay Security and Development Officer (BSDO) of Barangay Paltok, First District, Quezon City;

WHEREAS, based on his service record, he started as a BSDO volunteer from 1973 to 1991, became a regular BSDO from 1991 to 1995 and from 1995 till the time of his death, a barangay patrol driver;

WHEREAS, Mr. Ramos was driving the official barangay vehicle along Lung Center at East Avenue from an official mission when he had a heart attack;

WHEREAS, inspite of the sudden attack, he was able to control the vehicle he was driving;

WHEREAS, Mr. Ramos has nine (9) children and the only bread winner is his son Johnny, who is presently employed as a casual employee at the Boy Scout Council of Quezon City;

WHEREAS, the family's meager savings have gone to the funeral and other related expenses, and his family now faces an uncertain future;

WHEREAS, the granting of financial assistance to the bereaved family would serve as an inspiration to other government employees, most especially the BSDO's, to perform their duties and responsibilities well;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:



SECTION 2. This Ordinance shall take effect upon its approval.


