ORDINANCE NO. SP-1082, S-2001

AN ORDINANCE REQUIRING ALL OPERATORS AND OWNERS OF BUSINESS ESTABLISHMENTS ENGAGED IN ENTERTAINMENT AND AMUSEMENT OPERATING WITHIN THE JURISDICTION OF QUEZON CITY TO DISPLAY AND POST IN THEIR ENTRANCE OR CONSPICUOUS PLACE ALL THE RATES OF FEES AND CHARGES IMPOSED BY THEM OTHER THAN WHAT IS CUSTOMARILY OFFERED BY SAID BUSINESS ESTABLISHMENTS.

WHEREAS, it is observed that establishments engaged in entertainment and amusement business operating in Quezon City are charging fees and charges aside from the food, drinks and games being offered by them;

WHEREAS, the business establishments engaged in entertainment and amusement include the following;

- a. Amusement centers and establishments with coin operated machines, appliances, amusement rides and shooting galleries, side show booths and other similar establishments
- b. Billiard and/or pool halls
- c. Bowling establishments
- d. Circuses, carnivals and the like
- e. Cockpits
- f. Golf links and/or range
- g. Gymnasiums
- h. Night/Day clubs, discos and other similar establishments
 1. Night Clubs
 2. Day Clubs
 3. Cocktail lounges, bars or beer gardens
 4. Cabarets/dance halls
 5. Music lounges
 6. Sing-along restaurants/KTV's
- i. Off-track and off-fronton betting centers
- j. Resorts, swimming pools and similar establishments

- k. Skating Rinks
- l. Stadia and sport complexes
- m. Theaters and cinema houses
- n. Pelota courts and tennis courts and other similar nature

WHEREAS, the public who enters such establishments are entitled to know what are the other fees or charges to be imposed on them for availing of such entertainment and amusement beforehand or upon entering;

WHEREAS, it is only fair and just that all business establishments offering entertainment and amusement shall post the amount of fees and charges imposed by them in the entrances or conspicuous places of their establishment.

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. All operators and owners of establishments in Quezon City engaged in entertainment and amusement business shall display and post in the entrance of their establishment or in a conspicuous place the rates of fees and charges being imposed by them.


SECTION 2. Violation of any of the provisions of this Ordinance shall be punished by a fine of five thousand pesos (P5,000.00) or an imprisonment of one (1) year or both upon the discretion of the Court.


SECTION 3. This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation.
