ORDINANCE NO. SP-1093, S-2001

AN ORDINANCE RATIFYING AND AUTHORIZING THE COLLECTION OF FEES PURSUANT TO REPUBLIC ACT NO. 9048, OTHERWISE KNOWN AS THE "CLERICAL ERROR AND CHANGE OF FIRST NAME/NICKNAME LAW", AND ITS IMPLEMENTING RULES AND REGULATIONS, ADMINISTRATIVE ORDER NO. 1, SERIES OF 2001 OF THE OFFICE OF THE CIVIL REGISTRAR GENERAL OF THE REPUBLIC OF THE PHILIPPINES.

WHEREAS, under Section 18, last paragraph of the Implementing Rules and Regulations, Administrative Order No. 1, Series of 2001, promulgated by the Office of the Civil Registrar General pursuant to Republic Act No. 9048, otherwise known as the "Clerical Error and Change of First Name/Nickname Law", the local legislative body of the city or municipality concerned shall ratify the fees therein prescribed upon the effectivity of the Administrative Order,

WHEREAS, the same authority mentioned in the immediately preceding whereas clause hereof provides that "Prior to ratification of the local legislative body, all fees collected in connection with this Order shall go to the Local Civil Registrar's Office trust funds";

WHEREAS, the fees prescribed and collectible pursuant to the authority mentioned in the first whereas clause hereof shall inure to the benefit of the Quezon City government in accordance with the same authority.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Ratification, Adoption and Authorization. The prescribed fees provided under Section 18 of the Implementing Rules and Regulations promulgated by the Office of the Civil Registrar General, Administrative Order No. 1, Series of 2001, pursuant to Republic Act No. 9048, otherwise known as the "Clerical Error and Change of First Name/Nickname Law" is hereby ratified, adopted and authorized the pertinent provisions reproduced herein following.

SECTION 2. Authority to Collect Filing and Other Fees. The City Civil Registrar is hereby authorized to collect from every petitioner a filing fee in the amount of One Thousand Pesos (Php1,000.00) for the correction of clerical or typographical error and Three Thousand Pesos (Php3,000.00) for change of first name or nickname.

SECTION 3. Indigent Petitioner.- An indigent petitioner, referring to destitute, needy and poor individual who is certified as such by the Social Welfare and Development Office of Quezon City, is exempt from the payment of the fee mentioned in Section 2 hereof.

SECTION 4. Service Fees for Local Migrants.- In the case of the migrant petitioner, referring to one whose present residence or domicile, which must be within Quezon City, is different from the place where the civil registry record to be corrected was registered, there shall be a service fee of Five Hundred Pesos (Php500.00). In case the petition is for change of name, the service fee is One Thousand Pesos (Php1,000.00).

SECTION 5. Accrual to City Civil Registry Office Trust Fund.- Prior to the effectivity of his Ordinance, all fees collected pursuant to Republic Act No. 9048, and its Implementing Rules and Regulations, shall accrue to the trust fund of the City Civil Registry Office.
