ORDINANCE NO. SP-1104 S-2002

AN ORDINANCE ESTABLISHING THE PEDICAB REGULATORY SECTION UNDER THE TRICYCLE REGULATORY UNIT.

Introduced by Councilors RESTITUTO B. MALANGEN, ERIC Z. MEDINA, VOLTAIRE GODOFREDO L. LIBAN III, RAMON P. MEDALLA, ERIC Z. MEDINA, JORGE L. BANAL, DANTE M. DE GUZMAN, ANTONIO E. INTON, JR., JESUS "Bong" C. SUNTAY and JANET M. MALAYA.

WHEREAS, the City Council is empowered to regulate the use of st alleys, to establish terminals or regulate the use of the same and to regulate operation of conveyances for hire;

WHEREAS, the proliferation of passenger non-motorized tricycles or pedical have been noted which must be regulated to protect the general public.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. TITLE. - This Ordinance shall be known as the "Quezon City Pedicab Ordinance of 2002".

SECTION 2. DEFINITION OF TERMS.

PEDICAB: shall mean a three wheeled transport system wi motor and operated through human body and capable to transp passengers for a fee.

SECTION 3. FRANCHISE REQUIREMENT. - All operators of pa non-motorized tricycles or pedicabs are hereby required to secure from the Council a franchise by filing an application therefor with the Tricycle Franci Board. A franchise once granted shall be effective for three (3) years.

SECTION 4. REQUIREMENTS IN APPLYING FOR FRANCHISE.

1. Barangay Clearance where the operator seek to operate.

2. Clearance from Department of Public Order and Safety (DPOS) that the proposed terminal will not impair traffic flow.



SECTION 5. REGISTRATION.- Each passenger non-motorized tricycle or pedicab must be registered yearly with the Pedicab Regulatory Section of the Tricycle Regulatory Unit.

SECTION 6. THE PEDICAB REGULATORY SECTION. - There is hereby established under the Office of the Tricycle Regulatory Unit a Pedicab Regulatory Section to take charge in the processing of documents and other papers pertaining to passenger non-motorized tricycles or pedicabs and in the registration of the units. The Tricycle Regulatory Unit shall assign from among its existing personnel the employees who will compose the Pedicab Regulatory Section; Provided that the Board may submit to the City Council a recommendation for the creation of positions for the Pedicab Unit.

SECTION 7. FEES. - The following fees are hereby prescribed for the operation of a passenger non-motorized tricycle or pedicab:

- 1. Franchise Fee-----P 30.00 per unit
- 2. Registration-----P 50.00 per unit

SECTION 8. IMPLEMENTING GUIDELINES. - The Tricycle Regulatory Unit shall formulate guidelines in the implementation of this ordinance.

SECTION. 9. REPEAL.- All ordinances, rules and regulations inconsistent herewith are hereby repealed or modified accordingly.

SECTION 10. EFFECTIVITY. -. This Ordinance shall take effect immediately upon its approval.
