ORDINANCE NO. SP 1110, S-2002

AN ORDINANCE EXTENDING THE DEADLINE FOR THE RENEWAL OF MAYOR'S PERMIT ON BUSINESS FROM LAST WORKING DAY OF MARCH, 2002. TO APRIL 6, 2002.

WHEREAS, Her Excellency, President Gloria Macapagal Arroyo issued on March 11, 2002, Proclamation No. 164, declaring March 27, 2002 and March 30, 2002 a special (non-working) day throughout the country and allowing the private and public sector, under certain conditions, not to report for work on March 25, 2002 and March 26, 2002;

WHEREAS, Maundy Thursday, which falls on March 28, 2002 and Good Friday, which falls on March 29, 2002 are both regular public holidays;

WHEREAS, the renewal of Mayor's Permit to engage in business, is prescribed under Section 70 of Ordinance No. SP-91, S-93, otherwise known as the Quezon City Revenue Code of 1993;

WHEREAS, the above-mentioned non-working days will shorten the period allowed to all persons engaged in business, trade or activity within the city, to renew their permits;

WHEREAS, in the interest of the tax-paying public of Quezon City, the deadline for renewal of business permits should be extended to April 6, 2002 to offset the optional and legal holidays above-mentioned.


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. COVERAGE.- The renewal of Mayor's Permit to engage in business (Business Permits) which may be due on or before the last working day of March 2002 is hereby extended to April 6, 2002, without any penalty, surcharge or interest.

SECTION 2. EFFECTIVITY.- This Ordinance shall take effect upon its approval.


