AN ORDINANCE RENAMING TATALON ELEMENTARY SCHOOL TO DIOSDADO P MACAPAGAL ELEMENTARY SCHOOL

Introduced by Councilors JANET M. MALAYA, JESUS "Bong" C. SUNTAY, ALMA F. MONTILLA, ANTONIO E. INTON, JR., RICARDO R. DEL ROSARIO, RESTITUTO B. MALAÑGEN, WILMA AMORANTO-SARINO, VINCENT P. WHEREAS, Section 13, Paragraph b (3) of the Local Government Code of 1991 authorizes the Sangguniang Panlungsod of highly urbanized cities, in consultation with the National Historical Institute (NHI), to change the name of public elementary, secondary and vocational or technical schools, community colleges and non-chartered colleges;

WHEREAS, renaming of Tatalon Elementary School to Diosdado P. Macapagal Elementary School is a fitting tribute to the late President Diosdado P. Macapagal;

WHEREAS, the Barangay Council of Barangay Tatalon adopted Resolution No. 070, S-2001, requesting the Quezon City Council to change the name of Tatalon Elementary School to Diosdado P. Macapagal Elementary School as it will redound to the greater honor of the elementary school and to the late President Diosdado P. Macapagal for the following reasons:

- 1. No school in Quezon City has been named after the late President Diosdado P. Macapagal and
- 2. To accord due honor to a great statesman who was the 9th President of the Philippines.

NOW. THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The name of Tatalon Elementary School located at Victory Avenue. Barangay Tatalon, Quezon City, is hereby changed to DIOSDADO P. MACAPAGAL ELEMENTARY SCHOOL.
