ORDINANCE NO. SP-1163 S-2001

AN ORDINANCE AMENDING SECTION 5 OF ORDINANCE NO: SP-15, S-92, AS AMENDED BY ORDINANCE NOS. SP-351, S-92, SP-479, S-96, SP-787 S-99, AND SP-1062, S-2001, WITH REGARD TO THE COMPOSITION OF THE QUEZON CITY TRICYCLE FRANCHISING BOARD.

WHEREAS, the last reorganization of Quezon City Tricycle Franchising Board by virtue of Ordinance No. 1062, S-2001, limited the participation therein of the tricycle associations to a lone membership for the entirety of all such associations in Quezon City;

WHEREAS, the Quezon City Tricyle Franchising Board is the primary organ tasked with the management and implementation of rules and regulations affecting the conduct of tricycle operations within Quezon City;

WHEREAS, the tricycle associations mentioned in the first whereas clause hereof are the most affected where it concerns the infer and regulations mentioned in the second whereas clause hereof:

While Rivers the reorganization mentioned in the first whereas clause hereof elicited and of an artist dem among the tricycle associations in Quezon City as restricting their prefeightion in the premier body directing and supervising their conducts and affairs.

NOW, THEREFORE,

EL II ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 5 of Ordinance No. SP-15, S-92, as amended, is hereby further amended to read as follows:



"SECTION 5. QUEZON CITY TRICYCLE FRANCHISING BOARD. The Tricycle Franchising Board under the Sangguniang Panlungsod shall be composed of the following:

- 1. The Chairman of the Committee on Transportation and Communication, as Chairman;
- 2. The Chairman of the Committee on Barangay Affairs and Community Relations, as Member;
- 3. The Head of the Department of Public Order and Safety, as Member;
- 4. The Head of the Tricycle Regulatory Unit, as Member;
- 5. A representative from the non-governmental organizations duly accredited by the city government, as member (to be determined by the Quezon City Council); and
- 6. The representatives from the 5 Federation Districts of the Quezon City Tricycle Operators and Drivers Association (TODA) Federation, as members in the alternative, to exercise the representation herein mentioned where it is his/her Federation District's concern which is affected. Provided, that where the issue or question at hand concerns, directly or indirectly, all Tricycle Operators and Drivers Associations in Quezon City, the Federation District Representatives, shall select from among themselves their representation in the Board.

The representative from the non-governmental organizations shall be elected at large by the presidents of the associations duly accredited. He shall be entitled to a per diem of Seven Hundred Fifty Pesos (P750.00) per meeting attended

The Federation District Representatives shall be elected by respective Federation Districts. They shall be entitled to a per diem of Two Thousand Five Hundred Pesos (P2,500.00), to be divided equally among such representatives, without regard to whoever among them shall exercise the representation per meeting attended.

The non-governmental organization and Federation District Representatives shall hold office for one (1) year reckoned from the time of their election which shall be set by the Board within a reasonable time after the effectivity of this Ordinance."
