ORDINANCE NO. SP. 1852 S-2008 (PO2008-08)

AN ORDINANCE PROHIBITING THE USE DURING NIGHTIME OF A MOTOR VEHICLE WITHOUT A PROPERLY FUNCTIONING HEADLIGHTS AND OTHER SAFETY LIGHTS, AND IMPOSING PENALTY FOR ITS VIOLATION.

WHEREAS, the absence of headlights and other safety lights, or the malfunction thereof, is among the major causes of road traffic accident not only in Quezon City but the whole of Metro Manila and other parts of the country;

WHEREAS, the General Welfare Clause under Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, vests local government units with the police power to regulate activities in order to promote public safety, peace and order;

WHEREAS, the Sangguniang Panlungsod is empowered to regulate vehicular traffic pursuant to Section 458 (5) (vi) of the Local Government Code.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Motor vehicles are hereby prohibited from using the highways, avenues, roads, streets and other thoroughfares of Quezon City from 6:00 in the evening until 6:00 in the morning of the following day without a properly functioning and complete set of headlights and other safety lights. Whenever in use on the road, and unless they are parked, the headlights of all motor vehicles in Quezon City must be switched on at the proper intensity at all times, and the same cannot be switched off by reason only of slow movement of traffic.

SECTION 2. Violation of this ordinance shall be deemed a traffic violation to be meted a fine not exceeding One Thousand Pesos (P1,000.00).

SECTION 3. This Ordinance shall be enforced by the Office of the City Mayor, Honorable Feliciano R. Belmonte, Jr., through the Department of Public Order and Safety.
