ORDINANCE NO. SP-1865, S-2008 (PO2008-73)

AN ORDINANCE REQUIRING ALL CINEMA OWNERS AND OPERATORS IN QUEZON CITY, TO INCREASE THE PRICE OF THEIR ADMISSION TICKET BY ONE PESO (P1.00) COVERING THE PERIOD FROM DECEMBER 1 TO 31, 2008 TO SUPPORT THE PROGRAMS AND ACTIVITIES OF THE FOUNDATION FOR QUEZON CITY'S PRIDE, INC. (ORGANIZATION OF RETIRED POLICEMEN OF QUEZON CITY POLICE DISTRICT).

WHEREAS, the Foundation for Quezon City's Pride, Inc. has been organized to promote the welfare of the retired policemen of the Quezon City Police District (QCPD);

WHEREAS, one of their programs is the continuous medical treatment of the ailing retired policemen who, due to old age, are suffering from various sickness and the scholarship grant for their children;

WHEREAS, due to limited funds and in order to support the said activities, the help of the private sector is an imperative need.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. All cinema owners and operators in Quezon City are hereby required to increase their theater fees by One Peso (P1.00) covering the period from December 1 to 31, 2008.

SECTION 2. All proceeds of their fund raising shall be used solely to finance the programs and activities of the Foundation for Quezon City's Pride, Inc. (Organization of Retired Policemen of Quezon City Police District) and a corresponding financial report shall be submitted to the City Council for its information.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
