ORDINANCE NO. SP. 1982-2009

AN ORDINANCE GRANTING A FRANCHISE TO SACRED HEART VILLAGE MARKET FOR THE OPERATION OF A WET AND DRY MARKET AT ST. JUDE SACRED HEART VILLAGE, BARANGAY PASONG PUTIK, NOVALICHES, QUEZON CITY.

Introduced by Councilor FRANZ S. PUMAREN.

WHEREAS, Sacred Heart Village Market is located at St. Jude Sacred Heart Village, Barangay Pasong Putik, Novaliches, Quezon City with the primary purpose of operating a wet and dry market;

WHEREAS, Sacred Heart Village Market, through its representative Ms. Elvira Dael-Alzona, expressed the intention to apply for a franchise availing of the exemption granted under Ordinance No. 1271, S-2003, as amended, otherwise known as the Quezon City Market Code, considering that the market has been existing before the adoption of the Market Code;

WHEREAS, Engr. Jesus I. Dunca, Punong Barangay, Barangay Pasong Tamo Putik Proper, interposes no objection to the application of the said market;

WHEREAS, in order to give the nearby residents in the area, an easy access to a public market, it is imperative to grant Sacred Heart Village Market a franchise pursuant to Section 458 (3) VII of the Local Government Code;

WHEREAS, the Sangguniang Panlungsod is aware that a considerable number of public markets notwithstanding their lack of a franchise to operate as mandated, have timely and substantially complied with the provisions of the Quezon City Market Code.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. A franchise is hereby granted to Sacred Heart Village Market for the operation of a wet and dry market at St. Jude Sacred Heart Village, Barangay Pasong Putik, Novaliches, Quezon City.

SECTION 2. The franchise granted herein is subject to the conditions and limitations to be imposed and as required by the Market Code of 2000, other City Ordinances and National Laws.

SECTION 3. The franchise granted shall be for a period of five (5) years.

SECTION 4. This Ordinance shall take effect immediately upon its approval.
