AN ORDINANCE AUTHORIZING THE DONA IMELDA TRISIKAD DRIVERS ASSOCIATION (DITODA) ANDOPERATION OPERATE ONE HUNDRED TWENTY (120) TRISIKAD FOR HIRE PLYING WITHIN THE DESIGNATED ROUTES IN BARANGAY DOÑA IMELDA.

WHEREAS, the Quezon City government recognizes the an efficient and inexpensive mode significance of transportation facility as a basic necessity which should always be made available to the riding public, particularly in the interior areas of the city, to bring them towards the main thoroughfares within its jurisdiction;

WHEREAS, Doña Imelda Trisikad Operation and Drivers Association (DITODA) is a corporation duly registered with the Securities and Exchange Commission with Company Registration Number CN 200905425;

WHEREAS, the Barangay Council of Barangay Doña Imelda has authorized the operation of applicant DITODA to render service in the designated routes within its territorial jurisdiction through Barangay Resolution Numbered 159-5-2009;

WHEREAS, DITODA has been operating for over ten (10) years as part of the livelihood project of Barangay Dona Imelda.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Doña Imelda Trisikad Operation and Drivers Association (DITODA) is hereby granted the authority to operate One Hundred Twenty (120) trisikads-for-hire plying within the designated routes in Barangay Doña Imelda, District IV, Quezon City.

SECTION 2. This grant of authority shall be subjected to all existing laws, rules and regulations for trisikad service, violation of which shall cause the revocation or suspension of said authority.

SECTION 3. This Ordinance shall take effect upon its approval.
