ORDINANCE

EXTENDING FINANCIAL ASSISTANCE TO THE AUGUST 6
VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL
HOUSES OF ONE HUNDRED TEN (110) FAMILIES AT
BARANGAY TATALON, AREA 21, DISTRICT IV, QUEZON
CITY, AT ONE THOUSAND PESOS (\$\frac{P}_1,000.00) PER
FAMILY-OWNER AND FIVE HUNDRED PESOS (\$\frac{P}_500.00)
PER FAMILY-RENTER/SHARER, AND APPROPRIATING
THE SUM OF SIXTY EIGHT THOUSAND FIVE HUNDRED
PESOS (\$\frac{P}_68,500.00) WHICH SHALL BE TAKEN FROM
THE CALAMITY OR EMERGENCY FUND OF THE CITY
GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF
FUND THEREOF.
