ORDINANCE

EXTENDING FINANCIAL ASSISTANCE TO THE AUGUST 6 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF ONE HUNDRED TEN (110) FAMILIES AT BARANGAY TATALON, AREA 21, DISTRICT IV, QUEZON CITY, AT ONE THOUSAND PESOS (P1,000.00) PER FAMILY-OWNER AND FIVE HUNDRED PESOS (P500.00) PER FAMILY-RENTER/SHARER, AND APPROPRIATING THE SUM OF SIXTY EIGHT THOUSAND FIVE HUNDRED PESOS (P68,500.00) WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUND THEREOF.
