ORDINANCE
GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF THIRTY THOUSAND PESOS (₱30,000.00) TO THE FAMILY OF THE LATE PO3 INOCENCIO R. FRAGATA, A MEMBER OF PNP (CPDC), WHO DIED ON AUGUST 18, 1992 WHILE GIVING AN IMMEDIATE RESPONSE TO AN ATTEMPTED ROBBERY IN MALABON, METRO MANILA; THE AMOUNT TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 1992 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR, OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
