ORDINANCE

APPROPRIATING THE SUM OF THREE MILLION SEVEN HUNDRED FIFTY ONE THOUSAND EIGHT HUNDRED NINETY PESOS (P3,751,890.00) FROM THE KABATAANG BARANGAY FUNDS HELD IN TRUST BY THE CITY GOVERNMENT COVERING THE PERIOD FROM 1985 TO 1992 FOR THE CONDUCT OF THE SANGGUNIANG KABATAAN ELECTIONS TO BE HELD ON OCTOBER 9, 1992, AND FOR OTHER PURPOSES.

WHEREAS, the City Government Operations Office of the Department of Interior and Local Government has prepared an Activity Design covering every and all aspects of the Sangguniang Kabataan Elections in consonance with the aforecited Resolution No. 2499 of the Commission on Election;

WHEREAS, the City Treasurer, Quezon City has certified to the balances of each of the 140 KB Funds in Quezon City from CY 1985 to 1992 kept in trust in the City Treasury in the amount of Seven Million Sixty Three Thousand Seven Hundred Forty One Pesos and Eighteen Centavos (\$7,063,741.18);
