ORDINANCE
EXTENDING FINANCIAL ASSISTANCE TO THE MARCH 16 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF SEVENTY-EIGHT (78) FAMILIES AT BARANGAY TATALON, AREA 21, DISTRICT IV, QUEZON CITY, AT TWO THOUSAND PESOS (\$2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (\$1,000.00) PER FAMILY RENTER/SHARER, AND ALLOCATING THE SUM OF ONE HUNDRED TEN THOUSAND PESOS (\$110,000.00) WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE
