**ORDINANCE** 

INCREASING THE INCENTIVE ALLOWANCE OF THE FIFTY (50) INQUEST PROSECUTORS OF THE OFFICE OF THE CITY PROSECUTOR, QUEZON CITY FROM ONE THOUSAND FIVE HUND-RED PESOS (\$1,500.00) TO TWO THOUSAND FIVE HUNDRED PESOS (\$2,500.00) FROM JULY 1, 1993 TO DECEMBER 31, 1993, AND ALLOCATING THE SUM OF THREE HUNDRED THOU-SAND PESOS (\$300.000.00) FROM THE APPROVED LUMP SUM APPRORPIATION OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (\$1,500.000.00) UNDER THE INTER-AGENCY COMMITTEE ON JUSTICE IN QUEZON CITY UNDER THE SPECIAL PROJECTS OF THE OFFICE OF THE MAYOR, PURSUANT TO EXECUTIVE ORDER NO. 2, \$-92.
