ORDINANCE NO. SP-113, S-93

AN ORDINANCE DIRECTING THE QUEZON CITY ZONING REVIEW COMMITTEE, AS PROVIDED IN THE IMPLEMENTING RULES AND REGULATIONS OF ORDINANCE NO. SP-22, S-92, OTHERWISE KNOWN AS "THE QUEZON CITY ZONING ORDINANCE OF 1992", TO REVIEW THE EXISTING ZONING CLASSIFICATION AND/OR ZONING BOUNDARIES OF QUEZON CITY AND TO DRAFT AND SUBMIT TO THE CITY COUNCIL FOR APPROVAL ITS RECOMMENDATIONS FOR REZONIFICATION, AND PROVIDING THE NECESSARY FUNDS THEREFOR.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Quezon City Zoning Review Committee, as provided in the Implementing Rules and Regulations of Ordinance No. SP-22, S-92, otherwise known as "The Quezon City Zoning Ordinance of 1992", is hereby directed to review the existing zoning classifications and/or boundaries of Quezon City, and on the basis thereof, to draft and submit to the City Council for approval, its recommendations for rezonification.

SECTION 2. The Quezon City Zoning Review Committee shall be assisted in its task by the City Planning and Development Office and such other agencies and offices of the City government and shall be further augmented by contractual employees who shall be hired for the purpose as herein provided.

SECTION 3. There is hereby appropriated for the purpose, the amount of FIVE MILLION PESOS (P5,000,000.00) from any available funds in the City, broken down as follows.
