ORDINANCE NO. SP- 116, S-94

AN ORDINANCE AUTHORIZING THE PAYMENT OF MONTHLY ALLOWANCE TO ONE (1) POLICE INSPECTOR AND NINETEEN (19) MEMBERS OF THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY, QUEZON CITY JAIL, SIMILAR TO THE MONTHLY ALLOWANCE BEING GRANTED TO POLICE OFFICERS OF QUEZON CITY, APPROPRIATING THE AMOUNT OF ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00) FOR THE PURPOSE TO BE TAKEN FROM ANY AVAILABLE FUNDS OF THE CITY, THE SAME TO TAKE EFFECT ON JULY 1, 1993.

WHEREAS, the Administration of this City feels the "silent" dissatisfaction of its constituent-workers particularly the uniformed men and women as regards their salary and that it clearly realizes the connection between dissatisfied public servants and the rising rate of corruption that it desires to carefully classify and equalize jobs vis-a-vis the corresponding compensation;
