ORDINANCE NO. SP-137, S-93

AN ORDINANCE GRANTING MONTHLY FINANCIAL ASSISTANCE TO EVERY BARANGAY CAPTAIN, KAGAWAD, SECRETARY, SANGGUNIANG KABATAAN CHAIRMAN AND TO ALL BSDO EXECUTIVE OFFICERS, REGULAR BARANGAY SECURITY DEVELOPMENT OFFICERS (BSDO) OF QUEZON CITY, EFFECTIVE JANUARY 1, 1994 UP TO JUNE 30, 1994, THE FUNDING REQUIREMENTS THEREFOR IN THE TOTAL AMOUNT OF NINETEEN MILLION SIX HUNDRED SIXTY-FIVE THOUSAND PESOS (P19,665,000.00) OR SO MUCH THEREOF TO BE AUTHORIZED IN THE 1994 ANNUAL BUDGET.

WHEREAS, under City Ordinance No. SP-95, S-93, the Barangay Treasurers were given monthly financial assistance of two thousand pesos (P2,000.00) each by the City government;

WHEREAS, the additional allowance granted to the Barangay Treasurers by the City government is in recognition of the important functions, duties and responsibilities bestowed upon them under the provisions of the New Local Government Code of 1991 (RA 7160) and in the implementation of the Quezon City Revenue Code of 1993;

WHEREAS, the other Barangay Officials, particularly the Barangay Captains, Kagawads, Secretaries and SK Chairman and Kagawads of the Sangguniang Kabataan and BSDO's also perform functions, duties and responsibilities which are of equal importance in the barangay governance with that of Barangay Treasurers;
