HE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Provided they are found to be insurable, all Barangay Captains, Barangay Kagawads, Sangguniang Kabataan (SK) Chairmen, and SK Kagawads, Barangay Secretaries and SK Secretaries and Barangay Treasurers and SK Treasurers of Quezon City are hereby granted Health Care Benefits.

SECTION 2. The necessary fund requirement therefor is hereby appropriated from any available funds in the City Treasury to cover the cost of the initial premiums to be paid for said Health Care Benefits Funds required for the period January 1, 1994 to June 30, 1994.
