ORDINANCE NO. SP-223, S-94

AN ORDINANCE APPROVING THE SUBDIVISION PLAN WITH VERTICAL COMPONENT (TIERRA TOWNHOMES) OF LOT NO. 25, BLOCK NO. 18, PCN-2188 LOCATED AT 123 ESTEBAN ABADA ST., LOYOLA HEIGHTS, QUEZON CITY, CONTAINING AN AREA OF ONE THOUSAND SIX HUNDRED TWENTY-THREE SQUARE METERS AND THIRTY SQUARE DECIMETERS (1,823.3 SQ.
