AN ORDINANCE APPROVING THE CONSOLIDATION-SUBDIVISION PLAN OF LOT 4476-B-1-A, 4476-B-1-B AND 4476-B-1-C (LRC) PSD-312430 LOCATED AT OLIVEROS DRIVE, BARANGAY APOLONIO SAMSON, QUEZON CITY (ON SITE DEVELOPMENT - KAPISANAN NG MGA MARALITA NG APOLONIO SAMSON), CONTAINING AN AREA OF TWO THOUSAND TWO (2,002) SQUARE METERS COVERED BY TCT NOS. 93792, 94645 AND 94646 OF THE REGISTRY OF DEEDS OF QUEZON CITY, AS SUBMITTED BY MR. ARSENIO V. MASANGCAY, JR., PRESIDENT, KAPISANAN NG MGA MARALITA SA APOLONIO SAMSON OF 17-N OLIVEROS DRIVE, BARANGAY APOLONIO SAMSON, QUEZON CITY, SUBJECT TO THE MINIMUM REQUIREMENTS OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF BATAS PAMBANSA BLG. 220 AND TO THE CONDITIONS PRESCRIBED UNDER ORDINANCE NO. SP-56, S-92.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

The Consolidation-Subdivision Plan of Lot 4476-B-1-A, 4476-B-1-B and 4476-B-1-C (LRC) PSD-312430 located at Oliveros Drive, Barangay Apolonio Samson, Quezon City (On Site Development - Kapisanan ng mga Maralita ng Apolonio Samson), containing an area of Two Thousand Two (2,002) square meters, covered by TCT Nos. 93792, 94645 and 94646 of the Registry of Deeds of Quezon City, as submitted by Mr. Arsenio V. Masangcay, Jr., President, Kapisanan ng mga Maralita sa Apolonio Samson, is hereby approved, subject to the conditions prescribed under Ordinance No. SP-56, S-92, details of which are as follows:
