ORDINANCE APPROVING THE SUBDIVISION PLAN WITH VERTICAL COMPONENT OF LOTS 732-A-4 (LRC) PSD-75734; 732-B FLS-2182-D; AND 469-B, PSD-1726, (METROGREEN VILLAGE) COVERED UNDER TCT NOS. 118176, 118177 AND 118178 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF 40,078 SQUARE METERS LOCATED AT BARANGAY SAN BARTOLOME, NOVALICHES, QUEZON CITY, AS APPLIED FOR BY MR. JAIME L. FERNANDEZ, EXECUTIVE VICE-PRESIDENT, HOMEOWNERS DEVELOPMENT CORPORATION AND DURAWOOD CONSTRUCTION & LUMBER SUPPLY, INC. OF 154 KATIPUNAN AVE., ST.
