AN ORDINANCE APPROVING THE CONSOLIDATION-SUBDIVISION PLAN OF LOT 1-A, PSD-007404-020377-D AND LOT 2, BLOCK 6, PCS-5873 (THE BELLEVUE PHASE III), COVERED AND EMBRACED UNDER TCT NOS. 54890 AND 43617 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF EIGHTEEN THOUSAND SIX HUNDRED SEVENTY (18,670) SQUARE METERS, SITUATED IN BARANGAY APOLONIO SAMSON, QUEZON CITY, AS APPLIED FOR BY BELLEVUE PROPERTIES, INC., REPRESENTED BY TEODORO S.
