BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Subdivision Plan of Lot 2, Psd-13-011226 and Lot 2-B, Psd-13-011226 (Commercial Subdivision-Neopolitan Phase IV), covered and embraced under TCT Nos. 19714 and 19728 of the Registry of Deeds of Quezon City, containing an area of Two Hundred Twenty Nine Thousand Four Hundred Thirty Four (229,434) square meters, situated in Barangay Pasong Putik, Quezon City, as applied for by Sta.
