RT-100159 (301611) OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF FORTY THOUSAND (40,000) SQUARE METERS, SITUATED IN BARANGAY CALLYO OLIFTON CITY AS APPLIED FOR DV CTA LUCIA PEALTY SAUYO, QUEZON CITY, AS APPLIED FOR BY STA. LUCIA REALTY AND DEVELOPMENT CORPORATION, REPRESENTED BY WINIFRED G.
