ORDINANCE NO. SP-330, S-95

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LOT 1-B-2, (LRC) PSD-15624 (PHILIPS' NORTHPOINT PARK), CONTAINING AN AREA OF FIFTEEN THOUSAND (15,000) SQUARE METERS, COVERED BY TCT NO. 98063 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF SQUARE D DEVELOPMENT CORPORATION, LOCATED AT BARANGAY SAN BARTOLOME, NOVALICHES, QUEZON CITY, AS APPLIED FOR BY MR. DELBERT SIA, OF 407 DASMARINAS ST., STA. BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1.
