AN ORDINANCE APPROVING THE SUBDIVISION PLAN WITH VERTICAL COMPONENT OF LOT 873-A-2, PSD-13-018847 AND LOT 873-C, PSD-04-001151 (ROLLING MEADOWS, PHASES III-A & III-B) COVERED UNDER TCT NO. 46334 AND 46335 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AREA OF FIFTY EIGHT THOUSAND EIGHT HUNDRED FORTY (58,840) SQUARE METERS, SITUATED IN BARANGAY SAN BARTOLOME, QUEZON CITY, AS APPLIED FOR BY TRANS-UNION CORPORATION, REPRESENTED BY MR.
