ORDINANCE NO. SP. 2110, S-2011

AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO ALLOW MILLENIUM BINGO FUN GAMING CORPORATION TO ESTABLISH BINGO HALL AT THE 3<sup>RD</sup> FLOOR OF FMC BUILDING, DON MARIANO MARCOS AVENUE CORNER REGALADO AVENUE, FAIRVIEW, QUEZON CITY, FOR THE PURPOSE OF HOLDING BINGO GAMES, SUBJECT TO THE RULES AND REGULATIONS PROMULAGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Millennium Bingo Fun Gaming Corporation, is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal office at FMC Building, Don Mariano Marcos Avenue corner Regalado Avenue, Fairview, Quezon City;

WHEREAS, Millennium Bingo Fun Gaming Corporation has a pending application with the Philippine Amusement and Gaming Corporation (PAGCOR) for the issuance of its franchise to operate bingo games;

WHEREAS, Millennium Fun Gaminy Corporation seeks to operate binyo hall in Quezon City at 3rd Floor FMC Building, Don Mariano Marcos Avenue corner Regalado Avenue, Fairview, Quezon City and requesting the City Council to grant in its favor the corresponding permit for the purpose;

WHEREAS, under Republic Act No. 7160, the City Council has the authority to enact ordinances, granting franchises and authorizing the issuance of permits or licenses, and levying taxes, fees and charges;

WHEREAS, the Millennium Fun Gaming Corporation has been previously issued a Special Permit as provided in Ordinance No. SP-1442 S-2004;

WHEREAS, Millennium Fun Gaming Corporation is seeking for renewal through a letter to the Vice Mayor and Presiding Officer Ma. Josefina G. Belmonte dated October 18, 2010.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Subject to its franchise issued for the purpose by the Philippine Amusement and Gaming Corporation (PAGCOR), there is hereby granted a Special Use Permit to allow Millennium Bingo Fun Gaming Corporation to establish bingo hall at the 3rd Floor FMC Building, Don Mariano Marcos Avenue corner Regalado Avenue, Fairview, Quezon City and conduct therein bingo games.

SECTION 2. Millennium Bingo Fun Gaming Corporation shall secure the necessary Mayor's permit for the operation of the Bingo Hall.

SECTION 3. The authority to operate bingo hall granted herein shall be subject to the following limitations:

- a. The conduct and holding of bingo games shall be in accordance with the rules and regulations of the Philippines Gaming and Amusement Corporation (PAGCOR).
- b. The operation of bingo shall not include the playing of games not related to or other than the games of bingo.

SECTION 4. Upon approval of this Ordinance, the Millennium Bingo Fun Gaming Corporation shall remit to the City Treasurer in lieu of taxes, a franchise tax of fifty seven percent (57%) of one percent (1%) of the gross receipts and sales of Millennium Bingo Fun Gaming Corporation which shall be imposed and be made payable yearly to the City Treasurer during the lifetime of this Ordinance and renewal thereof.
