ORDINANCE NO. SP. 2134 S-2012

AN ORDINANCE PROHIBITING ALL PERSONS, ENTITIES, AND BUSINESS ESTABLISHMENTS IN QUEZON CITY TO CHARGE ANY FEE TO SENIOR CITIZENS, PERSONS WITH DISABILITY, AND EXPECTANT MOTHERS FOR THE USE OF ANY RESTROOM OR COMFORT ROOM AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, it is now the practice of some business establishments to charge a fee for the use of comfort rooms or rest rooms located within their establishment;

WHEREAS, due to this practice, most people who need to use the comfort room or restroom are constrained to look for the "free comfort room or restroom" which are oftentimes not easily accessible;

WHEREAS, the senior citizens, persons with disability and expectant mothers are at a great disadvantage since they are less mobile/incapable of walking further in order to respond to the "call of nature";

WHEREAS, this Ordinance seeks to provide preferential treatment our senior citizens, persons with disability and expectant mothers as regards easy access to public facilities like comfort rooms.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

Section 1. It shall be prohibited for all persons, entities, and business establishments in Quezon City to charge any fee or require any condition to senior citizen from Quezon City, all persons with disability and expectant mothers for the use of any restroom or comfort room.

Section 2. It shall be the duty of the senior citizen to present his/her senior citizen valid 1.D. issued by the Office of the Senior Citizens Affairs (OSCA) of Quezon City to the attendant/cashier of any pay restroom/comfort room located in Quezon City. No other I.D. shall be entertained.

Section 3. It shall be the duty of persons with disability and the expectant mothers to notify the person manning a pay comfort room/restroom that a person with disability and expectant mothers wish to use the pay restroom/comfort room. One who is totally blind or has lost any major part of his body (hands, arms, feet, or legs) or if the same is no longer functioning shall be automatically considered a person with disability.

Section 4. Penal Clause. — The individual owner of the establishment with pay rest room who shall prohibit or cause the prohibition of any senior citizen; as defined in Section 2 herein or a person with disability and expectant mothers in Section 3 herein from entering a pay restroom/ comfort room free of charge shall be penalized with a fine of Five Thousand Pesos (P5,000.00) or serve an imprisonment for a period not exceeding one year, or both, at the discretion of the courf if the establishment is owned by a partnership, the partners who own such establishment where such senior citizen, person with disability or expectant mothers is prohibited from entering a pay restroom/comfort room free of charge shall likewise be held liable for violation of this Ordinance. If the establishment is owned by a corporation, the President and/or Manager of such corporation shall be liable thereof.

Section 5. It shall be the duty of the establishment, person, or entity operating a pay restroom to put a prominent sign which states "Senior citizens of Quezon City, persons with disability and expectant mothers are Free of Charge". Failure to put said signage shall likewise result in penalties contained in Section. 4 hereof.

Section 6. All complaints of violation of this Ordinance shall be directed either at the OSCA or the Office of the Prinong Barangay where the violation occurred.

Section 7 Repealing Clause - All Ordinances and other issuances inconsistent herewith are hereby repealed or amended accordingly.

Section 8. Separability clause - If any provision of this Ordinance is subsequently declared as unconstitutional, the validity of the remaining provisions shall remain in full force and effect.

Section 9 Effectivity Clause - This Ordinance shall take effect immediately upon its approval.
