RESOLUTION NO. SP 1053, S-98

A RESOLUTION STRONGLY URGING THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR., TO AUTHORIZE THE IMMEDIATE RELEASE OF THE CASH GIFT AND 13TH MONTH PAY OF ALL QUEZON CITY HALL GOVERNMENT EMPLOYEES, INCLUDING THOSE WITH CONTRACT OF SERVICE APPOINTMENT, NOT LATER THAN NOVEMBER 30, 1998.
