RESOLUTION NO. SP 1061, S-98

A RESOLUTION RE-ESTABLISHING THE FLOW OF TRAFFIC FOR THE STREETS LOCATED AT BARANGAY MILAGROSA IN ACCORDANCE WITH THE TRAFFIC RE-ESTABLISHMENT PLAN APPROVED BY THE BARANGAY COUNCIL.

WHEREAS, the streets traversing Barangay Milagrosa, this City, are all owned and maintained by the Quezon City government;

WHEREAS, because of the convergence of schools such as Belarmino Elementary School and Jose P. Laurel High School and the public market in Project 4, traffic jams become a regular occurrence therein;

WHEREAS, there is a popular clamor among the affected parents of school children, teachers and the residents for the re-establishment of the traffic therein;

WHEREAS, the Barangay Milagrosa Council has approved a plan to re-establish the traffic flow at certain streets in the barangay;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to re-establish, as it does hereby re-establish, the flow of traffic for the streets located at Barangay Milagrosa in accordance with the traffic re-establishment plan approved by the Barangay Council, as follows:

During school days, from Monday to Friday, except during national and declared holidays, from 6:00 a.m. to 6:00 p.m., the flow of traffic for the following streets located at Barangay Milagrosa shall be as provided hereunder;

Handwritten initials at the bottom right corner.

1. Lakandula Street - two way Street
2. Belarmino Street - two way Street
3. Legaspi Street - one way from P. Tuazon Street going Poblete Street
4. Poblete Street - two way from Belarmino Street to Legaspi Street and Salalilia Street, one way from Salalilia Street going to P. Tuazon Street
5. Gregorio Street - two way from Lakandula Street to Salalilia Street
6. Salalilia Street - one way from the corner of Lakandula Street going and up to the corner of Gregorio Street, one way from the corner of Lakandula Street up to the corner of Poblete Street


RESOLVED, FURTHER, to enjoin the Barangay Milagrosa Council to install the necessary standard traffic signs in accordance with the re-established traffic flow in coordination with the concerned traffic enforcement/regulatory agencies.

RESOLVED, FINALLY, to enjoin the Barangay Milagrosa Council and concerned traffic enforcement agencies to strictly enforce the re-established traffic flow including all applicable penalties prescribed by pertinent laws, ordinances, and other issuances.
