A RESOLUTION URGING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS AND THE METRO MANILA DEVELOPMENT AUTHORITY TO IMPLEMENT THE NECESSARY DREDGING, CLEARING AND CLEANING OF ALL OBSTRUCTIONS IN RIVERS, ESTEROS AND ALL WATERWAYS IN QUEZON CITY IN PREPARATION FOR THE FORECASTED LA NIÑA PHENOMENON.

WHEREAS, the La Niña phenomenon is predicted to come in the month of August;

WHEREAS, most of the waterways in the city are silted and filled with floating trash and garbage which obstruct the natural flow of water;

WHEREAS, wheather forecasters have predicted that the La Nifia phenomenon will cause havoc to our environment which is expected to bring heavy and torrential rains that will fill the rivers, esteros and waterways in the city and could result in flash floods ;

WHEREAS, it is but necessary that all necessary preparations be undertaken to prevent or minimize flash floods and street floodings which can cause the destruction of street concrete and pavements;

RESOLVED, FURTHER, to urge the Department of Public Works and Highways to cause the removal of the illegal structures within the waterways in the territorial boundaries of Quezon City, and to include those who need to be relocated to their relocation site.
