RESOLUTION NO. ~~SP-1115~~ 3-99

A RESOLUTION URGING DRIVERS OF CARS, JEEPNEYS, BUSES AND OTHER MOTOR VEHICLES PLYING THE STREETS/ROADS OF QUEZON CITY TO PROVIDE A GARBAGE/REFUSE CONTAINER WITH COVER INSIDE THEIR RESPECTIVE VEHICLES.

WHEREAS, Presidential Decree No. 825 prohibits and penalizes the improper disposal of garbage and provides, among others, that "it becomes the duty of every citizen and resident of the Philippines to keep his environment or surroundings clean and wholesome," and that "all garbage, filth and other waste matters, shall be placed in the proper receptacles for the disposition thereof by garbage collectors;"

WHEREAS, certain drivers and passengers aboard speeding motor vehicles indiscreetly/indiscriminately throw garbage, filth and other waste matters on street pavements distracting/endangering motorists and making it hard for law enforcement authorities to pinpoint, identify or apprehend them for violation of PD 825;

WHEREAS, not only drivers of public utility vehicles are offenders or violators, but even drivers of private motor vehicles, as well, should be requested to provide these waste receptacles to minimize littering, if not totally eliminate indiscriminate throwing of waste materials in public places;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, drivers of cars, jeepneys, buses and other motor vehicles plying the streets/roads of Quezon City to provide a garbage/refuse container with cover inside their respective vehicles.
